Introduction

The Stanton City Parks and Recreations board is accepting quotes for light installation on existing poles on the High School Baseball field located at 127 Halls Lane, Stanton, KY 40380.

Here is a list of what we provide and what we require as part of the quote:

Details

What we provide:

- LED Light fixtures to be installed

What we require:

- **LED Light Installation**
 - Removal of old light fixtures from 8 current poles on the high school baseball field.
 - Secure and install new LED light fixtures to existing mounting hardware on poles.
 - Attach new LED light fixtures to existing wiring or install new wiring as needed for installation.
 - **New Poles**
 - 2 existing poles will need to be removed and new ones to be installed. Clark Energy is doing the demolition and installation of new poles.

- We will require the winning bidder to remove the mounting hardware from those 2 existing poles before demolition and add the mounting hardware and new LED light fixtures to the new poles once they are in place.
- These lights will also need to be attached to existing wiring or new wiring installed.
- **Testing and Alignment**
 - Once all new LED lights are in place they will need to be tested to determine that all wiring is in place.
 - Testing will also need to be done related to endurance of the lights for a 3- 4 hour period.
 - Alignment of the lights will need to be conducted after the installation and testing to limit glare and dark spaces on the field of play.
- **Materials Required**
 - Provide quotes of all materials needed.
